Linen, Leather & Lace 2019 - Terms and Conditions

As a Linen, Leather & Lace entrant, you must adhere to the following terms and conditions. Failure to act in accordance with these terms and conditions may result in your entry being disqualified.

Definitions:

“We/Australian Sewing Guild Ltd./Guild/ASG/Promoter” means Australian Sewing Guild Ltd. ABN 13 153 114 928, PO Box 1068, Cairns North, QLD 4870 Website: www.aussew.org.au.

“Linen, Leather & Lace” means an Australian Sewing Guild national promotional competition.

“Event” is the Linen, Leather & Lace promotional competition for the Australian Sewing Guild Ltd.

“Website/Websites” means the online information portal for the competition.

“Event Blog Page/ASG Blog/Blog Page” means the social media information portal for the competition.

“You/Entrant” means the person who registers as an entrant.

“Register/Registering/Registered” means completing the Linen, Leather & Lace entry form via the ASG Website

“Voter” means a person who has voted for an entry via the Blog Page.

“Materials/Material” means the intellectual property and content used for the competition.

“Promotional Period” means the duration of the competition.

“Linked Sites” means third party operated hyperlinks.

1. Registrations can be made via www.aussew.org.au/page/Competitions
2. We will not accept registrations from people residing in countries other than Australia and New Zealand.
3. Multiple entries are permitted. Each entry must be registered separately and each entry must be of a single item; multiple entries of the same item will be disqualified.
4. Each registration attracts an entry fee, payable to Australian Sewing Guild Ltd. ASG members - \$10 AUD; Non-members \$12 AUD.
5. People residing outside Australia or NZ cannot vote for a person who is taking part in Linen, Leather & Lace.
6. During your participation in the Linen, Leather & Lace competition, as an entrant, we will collect your personal information. Information about how the ASG collects and uses your personal information can be found [here](#) along with your privacy rights.

7. If you are under 16 years of age, you must have the express permission of a parent or guardian before entering the competition.
8. We may amend these Terms and Conditions at any time during the competition period. Upon amending Terms and Conditions we will re-post them on www.aussew.org.au. Entrants and voters will be bound by the amended Terms and Conditions from that time.
9. The Website and ASG Blog is run by the ASG and some pages may exist for this event only.
10. The content of the ASG website and Blog such as text, graphics, images and names (“Material”) is protected by Australian copyright law. Unauthorised use of the Material may violate these copyright laws.
11. Linen, Leather & Lace promotional period (“Promotional Period”) will run between Thursday, 15th November 2018 and Friday, 31st May 2019.
12. There will be seven prize packs awarded. Four (4) will be awarded to the judges’ choice and three (3) will be awarded to viewers’ choice.

Judges will pick five (5) finalists in each category, based on pictures and descriptions submitted. Finalists will be asked to post their entry to the address provided. All entries will be returned at no additional cost to the entrant.

Viewers’ choice will be based only on pictures submitted and determined by number of votes.

Winning entries and information about the winners to be published on the social media and/or website of the promoters.

13. To be eligible for a prize pack, an entry form must be completed in full and submitted, with all photographs and entry fee by 11pm on Friday, 31st May 2019. If a Linen, Leather & Lace entry form is not completed in full, then the entrant may not be eligible for the prize pack/s. We may, at our absolute discretion, reject an entry if the entry form has not been completed with sufficient detail or payment has not been made. This could include incomplete personal details such as full name and address.
14. Entries will be posted to the ASG Blog as they are received, but voting will not commence until 12.00pm (midday) on Monday 3rd June 2019. Voting will close at midnight on Sunday 30th June 2019.
15. A Voter may cast only one vote. The use of any agencies or automated software to submit votes will void all entries submitted by that person/entrant.
16. All winners will be finalised at 12pm (midday) on Monday, 1st July 2019 and will be notified within two (2) working days by email from Australian Sewing Guild Ltd.
